# **CUSTOM CATERING CONTRACT**

#### Menu

Colorado Plus Brew Pub can custom design menus to meet your needs. We use local resources and create seasonal menus. Due to changing seasons and market prices our menus and prices are subject to change at any time.

Menu selections must be submitted with the contract (please note a contract is required to secure the reservation). Although required in advance, menu selections may be modified at any time up until two weeks prior to your event. We do our best to accommodate modifications after this time. Our chefs can make just about anything that will retain our high standards for quality with in the buffet setting should you have something specific in mind.

## **Payment**

Complete payment is due in Full TWO (2) Weeks prior to event. All events are subject to one master bill and paid for using one or more of the following methods: credit card (limit 2), cash and/or check.

#### Tax and Fees

10% service charge is added to total. This charge covers catering supplies and administrative costs. For the delivery, 20% delivery fee is added to total (Max: 40 miles radius)

There are 8% Sales Tax added to total. If the client's organization is tax exempt, Colorado Plus Brew Pub must receive a certificate reflecting the client's exemption status no later than 5 working days before the event.

## **Cancellation Policy**

For a full refund of your deposit, cancellations must be submitted via regular post or email to a manager of Colorado Plus Brew Pub in writing before 15 days of the event. You must receive a return email or call confirming cancellation. Cancellation within 14 days of event will result in the 50% of the total. Cancellation within one week of event forfeits the total payment.

## **Change of Menu and Time Policy**

To provide a high quality dinning service, change of menu and/or time must be submitted via regular post or email to a manager of Colorado Plus Brew Pub in writing before 15 days of the event. You must receive a return email or call confirming change. Additional fee may be charged up to the items and/or the timeline.

#### Liability

If the guests would like to retain any leftovers, the client is responsible for any leftover food and beverage for proper refrigeration and storage of the food and for proper reheating following food safety guidelines.

Colorado Plus Brew Pub shall take no liability to alcohol at the event, and will hold no liability to any damages to your guests or event location on or off premises. All liquor permits and any additional insurance coverage is up to the client to purchase and organize and must be obtained and posted for perusal at the event location.
